To ensure a comprehensive and prioritized action plan, it is requested to provide your inputs on the following:

- Suggestions for new standards and specifications: Items for which new standards, specifications, and related documentation (e.g., Technical Guidelines, Test Schedule & Test Procedure, etc.) may be taken up by TEC.
- Prioritization of specific items: Assign priorities to specific items that should be taken up urgently in the next financial year.
- Revisions of existing documents: Items for which existing TEC documents Standards, Generic Requirements (GRs), Interface Requirements (IRs), Essential Requirements (ERs), Technical Guidelines, Test Schedules & Test Procedures are need to be revised due to significant developments in the concerned field.

The details of the existing documents, along with the list of concerned core divisions of TEC and their respective mandates, are available on the TEC website (https://www.tec.gov.in).

Please provide your inputs by email to ddgstd.tec@gov.in, dirsted.tec-dot@gov.in, and adsd.tec-dot@gov.in, positively by Sunday, 16 February, 2025. This will enable TEC to finalize the Annual Action Plan (AAP) for the year 2025-2026 at the earliest.
