Notice for Inviting Public Comments

Subject: Adoption of TSDSI transposed 3GPP standards for Release 15 to 18 as national standards as an outcome of TSG#108 (Total 333 documents), by Telecommunications Engineering Centre (TEC).

Telecommunication Engineering Centre (TEC), Department of Telecommunications (DoT) has approved a policy for the adoption of domestic/international standards into National Standards. "Standardisation Guide" – a policy document for the adoption of telecom and related ICT standards defines the process of adoption/ratification of TSDSI/international standards including institutional mechanism, process of adoption, maintenance of standards, numbering plan, stakeholder consultation etc.

- 2. Telecom Standards Advisory Committee (TSAC) a Standing apex committee under the chairmanship of DDG (Standardisation), TEC, has decided to initiate the process of Adoption of TSDSI transposed 3GPP standards for release 15 to 18 as national standards as an outcome of TSG#108 (Total 333 documents).
- 3. As a next step in adoption process, all stakeholders are requested to offer their comments on the above mentioned TSDSI transposed 3GPP documents. Here it is important to mention that the Telecommunications (Standards, Conformity Assessment and Certification) Rules, 2025, Rule 5, sub-rule (1) states that the draft standards are now published with a minimum consultation period of 60 days (previously 4 weeks).
