Subject: Inviting Nominations for formation of DCC, Sub-DCC, MF and DFC Group for the year 2022 for formulation of GRs/ IRs/ Standards by Mobile Technologies Division in TEC – Reg.

Dear Sir/Madam,

Greetings from Mobile Technologies Division, Telecommunication Engineering Centre (TEC).

TEC is a National Standardization Body which deals with the development of Standards/ Requirements/ Technical Specifications pertaining to digital communications. The development of such documents goes through a four stage process with the DCC (Development Coordination Committee) as the apex committee. The three other Committee/ Forum/ Group so constituted are the DCC Sub Committee, the Manufacturers Forum (MF) and the Draft for Comments (DFC) Group.

DCC is the apex body, which consists of industry representatives drawn from different Telecom Service Providers and Associations. DCC is the final body for recommending GRs/ IRs/ Standards for approval of Sr. DDG, TEC/ Head of TEC. A DCC member is ordinarily from the top management of a user organization or association capable of articulating the vision, plan and objective of his/ her organization/ association.

DCC Sub-Committee, which is a working level Committee sub-ordinate to the DCC, provides inputs to the DCC in the form of draft document prepared based on stakeholder's consultations. The nominated members of DCC are required to provide suitable nomination of their immediate juniors, who is technically competent in drafting technical standards/ specifications for inclusion in DCC-Sub Committee.

The MF consists of technical representatives of equipment/ device manufacturers, suppliers and their associations etc.

The DFC (Draft for Comments) Group consists of experts from a particular family of devices/ equipment/ network elements from R&D institutions, academic institutions, user organizations, service providers etc. Generally, Draft for Comments is forwarded to DFC Group members through e-mail for examination and furnishing their comments, if any, on e-mail itself.

As per the extant procedure, TEC is required to identify appropriate experts as members of DCC, Sub-DCC, MF and DFC Group. The Mobile Technologies division, which handles cellular technologies like GSM, CDMA, WCDMA, LTE/ LTE-A as well as IMT-2020 Mobile Technologies (viz. 5G), etc. is in the process of formulation of new GRs / IRs/ Standards, revision/ review of existing GRs/ IRs/ Standards during the year 2022. Accordingly, nominations for the DCC, Sub-DCC, MF and DFC Group under the aegis of Mobile Technologies Division, TEC are invited from concerned stakeholders/ industry representatives, TSPs and their Associations.
